The Chief Executive Officer, Society for Elimination of Rural Poverty, Andhra Pradesh, Hyderabad, being the State Implementing Agency (Rural), under the "Bangaru Talli" Scheme after due consultation with the State Implementation Authority (Urban), vide the reference second read above has raised certain difficulties in implementation of the "Bangaru Talli" Scheme, and requested for some clarifications while suggesting certain modifications in the Rules issued vide reference first read above.

2. Now, the Government have decided to amend the Andhra Pradesh Bangaru Talli Girl Child Promotion and Empowerment Rules.

3. Accordingly, the following Notification will be published in an Extraordinary Issue of the Andhra Pradesh Gazette, dated:26.11.2013.

4. The Chief Executive Officer, Society for Elimination of Rural Poverty, Andhra Pradesh, Hyderabad, and the Managing Director, Mission for Elimination of Poverty in Municipal Areas (MEPMA), Andhra Pradesh, Hyderabad shall take further necessary action in the matter accordingly.

NOTIFICATION

In exercise of the powers conferred by sub-section (1) of section 15 of the Andhra Pradesh Bangaru Talli Girl Child Promotion and Empowerment Act, 2013 (A.P. Act No.5 of 2013) the Governor of Andhra Pradesh hereby makes the following Amendments to the Andhra Pradesh Bangaru Talli Girl Child Promotion and Empowerment Rules, 2013 issued in G.O.Ms.No.307, PR & RD (RD.II) Department, Dt.29.06.2013.

AMENDMENTS

(i) In the said rules, in rule 4 for sub rule (2) the following shall be substituted, namely:-

"If the child born is a girl child, the particulars of the birth shall be uploaded by the Village / Ward implementation authority (VIA/WIA) in **Form II** into the central registry using the online data entry process along with the following documents names."

- (a) Birth certificate issued by the Registrar of Births and Deaths at the Gram Panchayat / ward level
- (b) Photograph of the girl child and her mother / guardian
- (c) The Aadhar number of mother / father / guardian

- (d) Ration cards of type RAP, AAY/YAP, TAP Banda are eligible for the Bangaru Talli Program belonging to mother/father/guardian
- (e) Copy of the bank account of the mother/father/guardian, which shall later be replaced by the bank account of the girl child after she attains the age of (seven)(7) years.
- (ii) For sub rule (5) of Rule 4, the following shall be substituted, namely:-
- (5)"Aadhaar identity issued by the Unique Identity Authority of India shall be mandatory for registration of new entries. Provided for registrations done till 31st December 2013, a further time of three (3) months may be given for securing the Aadhaar number."

For sub rule (2) of Rule 6 the following shall be substituted, namely:-

- (2)"It shall be the responsibility of the Authentication Authority to verify personally regarding the accuracy of such entry or updation and authenticate the same online, and if online facility is not available through paper certification, within fifteen (15) days from the date of such entry or updation".
